ABOUT YOUR CLUB

Established in 1980, the Goonawarra Golf Club is a limited liability company, one of the youngest in the metropolitan area, a member of Golf Victoria, a Member of the Northwest Region Golf Association, and the Ladies North-West District Pennant Association. The Club has the use of Clubhouse facilities and access to the Goonawarra Golf Course under conditions laid down in the Land (Goonawarra Golf Course) Act 1988. The following is a simplified explanation of the rights of Club Members under the Act.

- The Club Leases an area described as the Clubhouse and its immediate surrounds. The lease is for an initial five-year period and provides options for renewal until the year 2058.
- Club Members have exclusive use of the course. The times of this exclusive use must be negotiated with the course owner (presently the City of Hume) or, if not agreed to, determined by the Minister responsible for the Act.
- The Act Specifies the rights and responsibilities of the Club, the City of Hume, their respective roles and the relationship between them.
